3.4 Overview of case mix within the unit

We have a 9 bedded unit with a mixed surgical and medical patient population. Patients are treated and cared for by a multidisciplinary team of intensivists, nurses and other allied health professionals. The management is consultant led with all admissions to the unit reviewed by a consultant intensivist with in 12 hours of admission. We have close links to local tertiary hospitals.

Our unit is expanding: we are looking at moving into a 15 (with ability to adapt to the hospitals needs with up to 20 beds) bedded unit by 2026. We are also actively working on training and incorporating ACCPs into our team.

Training

4.1 Details of training opportunities on the unit

Our unit is approved for stage 1 and 2 FICM, anaesthetic, ACCS and IMT training. We have also developed a focused training programme for foundation year 1 trainees and have received excellent feedback on this. We are able to offer point of care ultrasound and FUSIC heart training with supervision/mentorship for this.

We participate in national audit projects such as ICNARC, NELA.

Trainees are supported with participation in GPICS2 mapped quality improvement projects. Our unit has also provided placement for ITU experience to wider allied health professionals including students in respiratory and sleep sciences with positive feedback.

4.2 Details of departmental teaching

Thursday afternoon teaching (protected teaching time) with a rotational list of topics including journal club, basic sciences, case-based discussions, simulation, imaging and mortality/morbidity.

Weekly MDT meetings at which trainees participate and are encouraged to present cases they have assessed.

FICM trainee/StR led "Hot Case of the week" discussion once/week.

Wales FICM study days 10/year.

4.3 Details of clinical governance meetings days and / or M & M

Monthly departmental audit day that alternates with governance days (this is combined with the anaesthetics team)

M & M meetings every 4 – 5 weeks
